- 3. Purpose of processing**

We process personal data of website users for the purpose of:

- ensure the functioning of the website;
- analyse website traffic and optimise its functionality (e.g. through the use of cookies);
- Processing inquiries and communication sent via contact forms;
- Conduct marketing and informational activities, including informing about Sano's activities;
- protect against abuse and ensure the security of the website;
- fulfilling obligations resulting from legal regulations (e.g. regarding the storage of data for tax or accounting purposes).

4. Legal basis for processing

- Article 6(1)(a) of the GDPR – the user's consent (e.g. to the processing of data through cookies for analytical or marketing purposes);
- Article 6(1)(b) of the GDPR – processing necessary to process inquiries or conclude a contract;
- Article 6(1)(c) of the GDPR – processing necessary to comply with legal obligations;
- Article 6(1)(f) of the GDPR – the legitimate interest of the controller consisting in ensuring the functionality of the website, its security and traffic analysis in order to improve services.

5. Categories of relevant data

As part of the use of the website, we may process the following data:

- technical data: IP address, browser type, device type, operating system, time and duration of use of the website;
- data provided voluntarily by the user, e.g. in contact forms: name, surname, e-mail address, telephone number, content of the inquiry;
- data related to cookies, including data on user behavior on the website (more information can be found in our Cookies Policy).

6. Information about recipients of personal data

The recipients of personal data may be:

- persons authorized by the personal data administrator (employees, associates of Sano);
- IT service providers, including entities providing website hosting, analytical and marketing systems, tools for managing the content of the website;
- entities authorized under the law.

7. Period of storage of personal data

Personal data processed:

- on the basis of consent (e.g. cookies) – until the consent is withdrawn;
- for the purpose of processing inquiries – for the period necessary to respond and pursue claims, if any;
- for analytical and marketing purposes – for the time specified in the Cookies Policy or until the user objects.

8. Rights of the data subject

Users of the website have the right to:

- access to your data;
- rectify data;
- delete data (within the limits resulting from the provisions of law);
- restriction of processing;
- object to the processing of data;
- data portability;
- withdraw consent to the processing of data, if the basis for the processing was consent.

9. Right to lodge a complaint with a supervisory authority

The User has the right to lodge a complaint with the President of the Office for Personal Data Protection if they believe that the processing of their personal data violates the provisions of the GDPR.

10. Requirement to provide personal data

Providing personal data is voluntary, however, failure to provide some information (e.g. in contact forms) may prevent you from using some of the website's functions.

11. Source of personal data

Personal data is obtained directly from website users (e.g. through contact forms) or automatically when using the website (e.g. technical data, cookies).
